### Driving Directions to Virginia Mason Medical Center

Traveling south on I-5:

1. Take Union Street exit
2. Turn right on 7th Ave.
3. Turn right on Pike St.
4. Turn right on 8th Ave.
5. Turn left on Seneca St

Traveling north on I-5:

1. Take Exit 164A, Madison St.
2. Turn right on Madison
3. Turn left on 9th Ave

### Virginia Mason Medical Center Parking—badge access only for afterhours—badges do not work between the hours of 0900-1600

- **Benaroya Research Institute Garage (1201 Ninth Ave.):** Enter westbound from Seneca Street between Ninth Avenue and Eighth Avenue. Elevators provide access to the street level on the corner of Ninth and Seneca. 6'5" clearance. Only 4 NKC spots available during the day. If lot is full will need to park elsewhere. Need to park on 3<sup>rd</sup> level or below
  - Monday through Friday (attended): 6:30 a.m. to 6:30 p.m.
- **Ninth Avenue Garage (1100-1123 Ninth Ave.):** Enter from Ninth Avenue, across the street from the Buck Pavilion. This garage does not provide elevator access. 6'4" to 6'6" (lower level) clearance. Days and times this garage is attended (otherwise, prepay at paybox):
  - Sunday through Saturday: Open 24 hours
  - Monday through Friday (attended): 6:30 a.m. to 8 p.m.
  - Saturday: 8 a.m. to 4 p.m.
- **Lindeman Parking Garage (1201 Terry Ave.):**  
Enter westbound from Seneca Street between Terry and Ninth avenues. This lot is located underneath the Lindeman Pavilion. There is elevator access directly into the Lindeman Pavilion from this garage. 6'2" to 6'8" clearance.

### Storeroom/Equipment location

**Locked storeroom** on located on hospital level 9 Jones. PD and CRRT overflow supplies are kept—need key from dialysis treatment room.

**Equipment:** HD/RO machines kept in either in dialysis unit or storeroom on Level 9 Jones. Prismaflex and PD cyclers are kept in storeroom on Level 9 Jones.

**Locked treatment room:** 7<sup>th</sup> floor Main Hospital-- 773, door code is **214**.

**Other DOOR CODES:** Treatment room cabinet door: **36708**. 7<sup>th</sup> floor staff bathroom: **2144**. ER and Jones patient Elevators are badge access only.

### Orders/Medications/Documentation:

**Orders:** MD writes daily orders within Cerner for HD, PD, CRRT,

**Meds:** Heparin and Lidocaine 1% in Pyxis for dialysis. No medications are to be kept in supply carts. —

**DOH violation if found!!!**

**Treatment documentation:** Paper treatment log sheet. Chart medications given and blood administration in Cerner. Chart catheter dressing change and AVF/AVG assessment in Cerner. Use Cerner progress note template. I&O in Cerner.

Cerner Users Guide notebook is in 7<sup>th</sup> floor TR or ask primary RN or call Resource RN at 897-6722 for Cerner assistance. Call IT Services Helpdesk ext. 36402 for computer access problems including lost or expired passwords.

**Locations:** Plumbed rooms: There are 3 ICUs: main unit is on level 7 both north and south. An additional unit is on level 6. **Use backflow prevention valves in all non-plumbed rooms.**

- Unit locations—(see maps)
  - CCU—6<sup>th</sup> and 7<sup>th</sup> floor
  - Renal—17<sup>th</sup> floor
  - Neuro—17<sup>th</sup> floor
  - Ortho—11<sup>th</sup> floor Jones Tower
  - GI—10<sup>th</sup> floor
  - Oncology—15<sup>th</sup> floor
  - ACE unit—14<sup>th</sup> floor
  - Surgical Tele—8<sup>th</sup> floor
  - Medical Tele—9<sup>th</sup> floor
  - PACU unit—7<sup>th</sup> floor—same floor as Dialysis treatment room

**Charge slips** – are to be dropped off at the Dialysis Unit located on level 7.
