

Clarity Monthly Update June 2020

General Information

The 3rd Sunday of every month Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. Following is a general overview of those fixes and enhancements included in the June 14, 2020 Update.

What's Fixed in Clarity

1. Beginning with Assessments created after June 14, 2020, **Assessments configured to copy to Patient>Notes** will now display the actual assessment name in the Summary instead of the short name.
2. The issue in which the **most recent Hospitalization** was not appearing in **Patient Chart View** is resolved.

What's New in Clarity

1. The new Clinic report, ***Current Vascular Access by Patient Name**, summarizes and displays all accesses that have no end date for each patient. This will be helpful for reviewing, troubleshooting, or correcting access data.
2. **Organization>Insurance Companies and Organization>Insurance Company Contacts**: There are minor changes to field names and label fonts.
3. **Real-Time Charting Treatment Type**: To help prevent inaccurate **Treatment Type** documentation, if the **Treatment Type** selected in **Real-Time Charting** does not match the Treatment Type in the Patient>Patient Schedule an error message will display and the treatment type will not be saved.
4. **Associated Physician Group in Patient Care Team**: when a **Physician** entry is updated or added, the **Associated Physician Group** will automatically be updated or added with the same date.
5. **New Treatment Type will be created, called "No Treatment/Medication Only" for patients who arrive for HD but are not dialyzed.**
 - a. Will be available in RTC and VM beginning **July 1**.
 - b. This treatment type gives you the ability to chart a medication administration even when a treatment did not occur (for example: clotted access).
 - c. You can also use it to keep your RTC documentation for a Present, Not Dialyzed situation that occurs when a med was not given.
 - d. Change the treatment type to No Treatment/Medication Only before posting it.
 - e. This treatment type will not go to a bill.
 - f. It functions in the same way a PD or HH Office Visit does.
 - g. It will appear in Treatment History as "No Treatment/Medication Only"

6. The number of Treatment Types will be simplified from a total of 48 down to 23.

- a. There were quite a few very specific treatment types that shared the same billing codes and charge rates.
- b. Beginning **July 1**, the list of Treatment Types in RTC and VM will be simplified.
- c. Simplifying the list will hopefully make it easier for staff to choose the correct treatment type in RTC and VM.
