

Clarity Monthly Update

General Information

The 3rd Sunday of every month Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. Following is a general overview of those fixes and enhancements that occurred on Sunday, July 19, 2020 and additional changes approved by NKC's Change Control Board.

What's Fixed in Clarity


1. **E-Signature:** Prior to July 19, an E-Signature would be required of the clinician who entered an order when that order was changed or discontinued by a different clinician. This has been fixed. The clinician changing/discontinuing an order and the MD indicated as Ordered By for the change/discontinue will get the E-Signature. This change will only be seen with orders changed/discontinued after July 19.
2. **Medications without Diagnosis Codes Report:** the report will now correctly display the patients and dialysis medications that are missing an ICD10 code.
3. **Missed Treatments type:** The logic in RTC was updated to allow the treatment type to be changed to "Missed Treatment" regardless of the treatment type in the patient schedule.
 - a. Missed and Unentered Treatments report: will display in the "Missed" section but will not have a reason.
 - b. RTC Status: will display with a TxPosted time but no Stop Time.
4. **No Treatment/Medication Only type:** The logic in RTC was updated to allow the treatment type to be changed to "No Treatment/Medication Only" regardless of the treatment type in the patient schedule.
 - a. Missed and Unentered Treatments report: will display in the "Missed" section but will not have a reason.
 - b. RTC Status: will display with a TxPosted time but no Stop Time.
5. **Remove "postponed" from warning in RTC:** Visonex updated the RTC warning when posting a treatment if a Medication/Immunization has not been documented. They have removed the word, "Postponed," since that is no longer an option. You will now see, "*Medication XXXX needs to have a time and an option (Given/Done/etc) from the Medication/Imn tab.*"
6. **Medication Labels-Update to work with PDF:** Visonex has updated the Medication Labels report to now allow printing on Avery Labels 5160 when the

report is opened as a PDF. Previously, you could only print on labels when using Viewer mode.

What's New in Clarity

1. Medication and Dialysis Prescription Orders will have a new look.

- a. Administration Section:** The Order Method, Order Taken Date and Time, Order Taken By and Ordered By have moved to the top of the page.

- b. Signature Detail:** Creation and Discontinued Events that display at the bottom of the page are now separated.

- c. Enable End Now:** In order to use the End Now button, staff must first click the Enable End Now button. There are 4 required fields to complete; DC Order Method, DC Order Taken Date and Time, DC Order Taken By (Clinician to sign) and DC Ordered by (Phy to sign).
- d. Clinician to sign:** This note next to the Order Taken By field used to say, "Nurse." Changing to "Clinician" makes it less confusing and more likely that ARNP and Renal Fellow names are selected as the Order Taken By when they are the ones giving the order on behalf of the primary nephrologist. ARNPs and Fellows cannot sign as the Ordered By person.


2. Rejecting Orders

- a. **Rejecting a Dialysis Prescription or Medication Order** will automatically End the order. A reason is required as well as DC Order information.
- b. **Rejecting an Immunization Order or General Physician Order** will automatically discontinue the order.
- c. **Pop up messages** will appear when a clinician clicks the Reject button. The message will inform the user whether an administration has already been completed on the order and ask the user if they still want to reject the order.
- d. **Reject Reason:** the reason for rejecting the order is required. One of the following two messages will display:
 - i. **Dialysis Prescription:** "When you click Submit the Dialysis Order will be cancelled and a new order must be immediately entered. Tell the charge nurse about your actions. If you click Cancel the order will not be rejected and will be returned to the list to be signed."
 - ii. **Medication Order:** "When you click Submit it will automatically discontinue the order. Tell the charge nurse about your actions. If you click Cancel the order will not be rejected and will be returned to the list to be signed."
- e. **Immunization and General Physician Order:** Only the Reason boxes are required. The order will automatically be discontinued.
- f. **"Rejected"** will display in the order grid

- Entering Start Date and End Date at the same time.** If you enter a Start Date and an End Date in an order and you immediately sign it, you will only have the one E-Signature to complete. If you do not sign the order immediately, 2 orders will display in the E-Signature page. One for the Start order and the other for the future End Order.
- Using Dose Counter.** The DC order will appear for E-Signature after the last dose is given. The E-Sig will be sent to the Clinician who entered the order, not the Clinician who gave the last dose.
- The Census Report has been decommissioned:** This report was not designed to be used by organizations like NKC that have multiple clinics and did not give accurate values.
- Additions to the Treatment tab in RTC.** Added two new columns to the Treatment Detail grid. Total Fluid Removed (TFR) and Dialysate Flow Rate (DFR).
