

# Clarity Monthly Update

## January 2021

### General Information

---

The 3<sup>rd</sup> Sunday of every month Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. Following is a general overview of those fixes and enhancements that occurred on January 17, 2021.

### What's Fixed in Clarity

---

1. The Edge browser will no longer allow users to select days when "**On Selected Days**" was not selected.
2. The **Missed and Unentered Treatments Clinic** report has been updated for improved performance.

### What's New in Clarity

---

1. **Transplant History of Patients** is a Clinic report that lists each patient and transplant history based on the **Transplant Information** screen.
2. The **Registration>Insurance Information>Policies** Plan Type dropdown now includes "Medicare Advantage" and "Private". These will be reflected in the **Insurance Information by Company** and **Insurance Information by Patient** Clinic Reports. MBI Policy ID has also been added to these reports.
3. A **More Info** button takes the user to a link to Quick Reference Guides and a link to the *Merk Manual Professional* site. This button was added to the following screens for clinical decision support:
  - a. Medications
  - b. Problem List
  - c. Allergies
  - d. Dialysis PrescriptionsMake sure to click PDF. After the *Merk Manual* link, click "Accept All Cookies".
4. A link to **UNOS.org** will now appear at the bottom of the Registration>Transplant Management>Add/Edit **Transplant Waitlist** form. A username and password will still be required.
