

Clarity Monthly Update February 2021

General Information

On the 3rd Sunday of every month, Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. The following is a general overview of those fixes and enhancements that will occur on February 21, 2021 as well as additional updates made by NKC since the last update newsletter.

What's Fixed in Clarity

- 1. Chrome/Edge Patient Assessments columns were overlapping: An alignment issue was fixed in RTC and Patient Assessments when using Edge or Chrome as your browser.
- 2. Update General Information-CROWNWeb ID for new format: Visonex has updated the Registration>General Information page to allow the new ID format from EQRS in the CROWNWeb ID field. Prior to this fix, users were unable to save changes in the General Information screen if the CROWNWeb ID field had a new EORS ID that started with "3."
- **3. Mailing Labels clinic report-Update to work with PDF:** The clinic report, Mailing Labels, has been upgraded. The PDF output format will now display correct alignment.
- **4. Fix validations in Nursing Home page:** Visonex made some updates to the Organization>Nursing Homes screen. They added validation if a Nursing Home currently exists in the list when adding a new Nursing Home. They also updated the e-mail and zip code fields to have format validation.
- **5. Microbiology Report-Added more antibiotics information:** Visonex increased the character limit from 1024 to 2048 characters allowed for results in the lab interface. Going forward with this increase, more information will now display on the patient report, Microbiology Detail.
- **6. Report for ETC Model-Patients and Criteria:** Visonex has created a new date selectable clinic report called, ETC Model-Patient and Criteria, for ETC clients to help identify patients that meet the ETC model criteria. The report will display the patient's Insurance Plan Type, if they currently have dementia listed in their problem list, is currently in a nursing home, and if they had a failed transplant in the last 12 months. The report is separated into two sections; Patients that meet Criteria and Patients that Do Not meet Criteria. The information will not display correctly if the Plan Type is not updated in the patient's insurance information.



- **7. Applying Standard Format for "Updated by":** Visonex has updated several forms to have standard Updated By format in the footer-User Last Name, User First Name and User Title. Previously, the Title did not display.
- **8.** Upgrade Page Edit User Roles & Patient Groups from ASP to MVC: Visonex has updated the Maintenance>Edit User Roles and Organization>Patient Groups forms to new framework.

What's New in Clarity

- 1. Amended Plans of Care: Nurses, Dietitians and Social Workers can easily indicate their splitter was "Reviewed" if their original documentation is now more than 15 days before the POC call. If the Plan(s) of Care need to be amended because a patient's condition has changed since the original POC, they can document the specific plan(s) that have changed and the information in that text box will flow to the CIA lumper. This eliminates the need to recreate/complete an entire new splitter in these situations.
- 2. **Missed Reasons:** the list of reasons for missed treatments was updated for greater specificity.
- 3. **Physician CIA (Splitter) changes:** Areas of the Physician CIA (Splitter) that carry forward to the CIA lumper are now highlighted in purple to make it more obvious to the user.
- 4. Medication Management tool-Changes to the naming of the protocols: Incenter patients should have generic (name) medication orders entered as Epoetin Beta Methoxy Polyethylene Glycol and Paricalcitol. The protocols used in Medication Management have been renamed to help in-center nurses remember to select the generic medication names. The protocols are now named "Epoetin BetaMPG" and "Paricalcitol." The exclusion groups used in Registration>General Information have been renamed, "Patients Excluded from Epoetin BetaMPG" and "Patients Excluded from Paricalcitol" to match the protocols.
- 5. **Medication Management tool-** The screen for Epoetin BetaMPG Protocol has been reformatted. Lab values for Albumin and Reticulocytes have been removed. The last five Hgb values now display instead of the last three. The ESA orders appear directly under the Hgb values. The last two Ferritin and Iron Saturation values now display instead of only the last one. The Iron Product orders appear directly under the iron labs.



6. The Physician Rounding Dashboard and Primary Nephrologist Dashboard have had new links added to them:

- a. Physician Rounding Dashboard now has links to:
 - i. BP Trends report
 - ii. Home (Hemo) Visit Management
 - iii. Notes
 - iv. Patient Care Team
 - v. Patient Chart View
 - vi. PD Visit Management
 - vii. Physician Orders
 - viii. Report Wizard
- b. Primary Nephrologist Dashboard now has links to:
 - i. BP Trends
 - ii. MD Office Visit (Electronic)—this checklist should be used every time a patient is rounded-on, but the patient is not in-center on dialysis.
 - iii. Patient Chart View
 - iv. Physician CIA (Splitter)
 - v. Physician Orders
 - vi. Report Wizard
