

Clarity Monthly Update April 2021

General Information

On the 3rd Sunday of every month, Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. The following is a general overview of those fixes and enhancements that will occur on April 18, 2021 as well as additional updates made by NKC since the last update newsletter.

What's Fixed in Clarity

- 1. **Treatment Alerts not appearing in Red in Edge/Chrome:** Visonex fixed an issue in checklist where Treatment Alerts were appearing in Black text in Edge and Chrome. All browsers will now display Treatment Alerts in Red text.
- 2. Report Performance-Untranscribed Physician Orders report: This report is now date selectable and will display the number of Untranscribed Orders at the top that are outside that date range. The report also includes the number of days the order has been outside that date range.
- **3. Physician Rounding report:** This Clinic report has been updated by replacing the ESCO column with the current Patient Status code.
- **4. Medication Labels-Not lining up in Edge:** Staff can now run Medication Labels report and the labels will align properly on the label sheets in Internet Explorer, Chrome or Edge.
- **5. ADT-Remove additional line feed:** The ADT interface has been updated by removing the additional blank lines when MSGHeaderAndFooter is configured.

What's New in Clarity

1. **Immunization Updates:** Significant changes have been made to Immunizations screens and functionality. Please refer to Clarity's Immunization Update document. It can be found on the Clarity Home Screen or by going to Clarity>Help>Reference Material>Hot Topics. There is also a video recording of a webinar demonstrating the changes.





- b. There is now a Standardized Vaccine Catalog that functions like the medication formulary. This also sets the stage for interfacing with WAIIS, the Washington Immunization Information System.
- c. Data Migration. Only true immunizations will be recorded in the Immunization screen. NKC was using the screen to document TB-Tests/Results and Hepatitis results/titers.
 - i. TB tests and results will now be documented in Patient>Tests & Procedures.
 - ii. Hepatitis lab results will now be documented in Laboratories.
- d. RNs will schedule immunizations to be given during a treatment (RTC or VM Office Visit) and chart the immunization as Given in the tx.
- e. The screens used to chart the administration during a treatment are more complete.
 - i. Includes lot #, Exp Date, Injection Site and VIS in one place.
- f. When the treatment is posted, the status of the scheduled immunization will automatically change to Administered in Clinic.
- g. If a patient declines to receive the immunization on the day scheduled, it can be rescheduled to the next Regular Schedule appt date by selecting "Postpone."
- h. RNs can still record an immunization that was Administered Elsewhere.
- i. New reports will be available.
- j. Clients with billing interface will need to re-enter charge codes.
