

Clarity Monthly Update

October 2021

General Information

On a monthly basis Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. Following is a general overview of those fixes and enhancements that will occur on October 18, 2021.

What's Fixed in Clarity

1. **Added new choice for TB test Aplisol:** Visonex added Aplisol 0.1 mL as a choice in Tests and Procedures>TB Test, PPD.
2. **General Physician Orders from Visit Management need to display as signed by Physician:** Physician Orders were not crossing from Visit Management as signed by the Physician. Orders from the Physician tab of VM PD and VM HH are now working like Real Time Charting. Any orders entered by the Physician will now display as signed by the physician.
3. **Medication-Uncheck Add to Patient's Current Problem List:** On the Medications form, the Add to Patient's Current Problem List will only be checked automatically if the ICD10 code is not currently on the patient's problem list. If the justification is already associated to the patient's problem list the checkbox will remain unchecked
4. **User Preference-update wording of User hidden in dropdown:** Visonex has updated the wording on the User Preferences page for Users Hidden in dropdown since there was confusion. It will be update to:
 - "User Hidden in Dropdowns (WARNING: disables user from being able to save in RTC)"
 - *This Checkbox is typically only selected if the user is no longer with the facility and their account is set to disabled in Organization Management.*
5. **Organization Management Reports-ability to view in Excel:** The User Reports in Organizational Management can now be run in Excel. In future releases, Visonex will be making more improvements for how the reports display in Excel.

6. **Organization->Pharmacy--Unable to update:** Visonex fixed an issue seen when updating Pharmacy information off the Organization Menu. Staff will no longer see an error.
7. **Critical: Update NDC codes and VIS Information:** This was deployed 9/13/2021. Visonex updated NDC codes for Flu vaccines along with the VIS dates.

What's New in Clarity

1. **4 New Unbillable Treatment Types:** The following new treatment types were created by NKC so that nurses can post treatments that will not be billed but still retain documentation of patient encounters. Rather than enter a missed treatment with reason, PND, and then delete the RTC from Checklist History, the nurse can simply change the treatment type and then post the treatment.
 - No Treatment-Phys Rounding Note Only
 - Present, Not Dialyzed-Access Issue
 - Present, Not Dialyzed-Medically Unstable
 - Present, Not Dialyzed-Patient Choice
