

Clarity Monthly Update

February 2022

General Information

On a monthly basis Visonex updates Clarity with fixes to issues reported and enhancements based on client feedback. Following is a general overview of those fixes and enhancements that will occur on February 21, 2022

What's Fixed in Clarity

1. **Dose Counter meds not ending when Regular Schedule is updated:** Dose Counter meds were not ending after the final dose when the patient's Regular Schedule was updated. This has been fixed. Now, when a patient's Regular Schedule is updated and a Dose Counter medication is affected by the schedule change, the medication will end once the final dose is given.
2. **Patients Needing a Permanent Access & Current Vascular Access by Patient Name report-the More Information feature has been updated.** The More Info feature of this report has been updated.
3. **UF Calculator-update:** The UF Calculator's Treatment Time field was broken and would not allow the user to change the treatment time. The UF Calculator would not open if the Dry Weight was listed as "TBD." Both of these bugs have been fixed.

4. Visit Management-Standardized and Improved the behavior of the Calendar in Home Treatment tab: The Calendars in the Home Treatment tabs for Home Hemo and PD will now function the same way.

Changes include the following:

- If the user sees a "V" - they will recognize this as a Visit/Treatment Type and no Home Tx is posted.
- If the user sees a "+" - they will recognize this as a 'Combined Treatment' - which also displays 'Combined Treatment' in the Detail Grid. Combined Treatments will now display individually on the patient's Treatment History Form. Clients may want to reference that Form when reviewing EOM (end of month) treatments.
- Blue treatment - "Light Blue" refers to an Unposted Portal Tx and "Darker Blue" refers to Unposted Home Tx.
- Green treatment - "Light Green" *without* any symbols - means a posted Home Tx. "Darker Green" means a posted NonHome Tx that occurred in RTC or in the Enter Treatment Form. In most cases, this is an "Incenter HD Treatment".
- Remember only Home Treatments will display in the lower Detail Grid.

Is there a Visit that isn't posted? Currently, there isn't a way to capture that on the Home Treatment calendar. However, we are working on a report that will capture this information. Clients need to keep that in mind in their workflow for Home Programs and Post (Add) Treatments timely.



5. Patient Assessment-unable to update Checkbox or Radio Button lines:

There was an issue with the Patient Assessment Editor. When updating lines that had a checkbox or radio button, an error would result. This is now resolved.

6. BBraun-Updated interface to allow 2 BPs with same result if time is different.

Prior to this fix, if a patient had the exact same BP twice in succession, the second one would not be allowed to flow to Clarity. This is now resolved.

7. **Critical-Immunizations- Update VIS edition dates for COVID vaccines:** the latest dates for EUAs (Emergency User Authorizations) for COVID were deployed 10/28/2021.
8. **Treatment History causing errors:** Visonex fixed a bug that was associated with Treatment History. Specifics of this error were not included in Visonex' update document.

What's New in Clarity

1. **COVID Emergency Use Authorization (EUA) update for Janssen and Janssen vaccine :** The latest EUAs have been deployed for Janssen COVID vaccines-issued 1/11/22. This information is now available in Clarity.
2. **New Menu, located off Help Menu-“Service Status.”** All users with the 00-Basic role will be able to view a new menu located off the Help Menu called, “Service Status.” This will display any incidents; past or present in Clarity Identity Management and Organization Management.
3. **Race and Ethnicity- Update standard values-** The values for Race and Ethnicity have been standardized in Clarity for ease of regulatory reporting to government agencies like EQRS and CMS
