

# Clarity Monthly Update January 2023


# **General Information**

On a monthly basis Visonex updates Clarity with fixes to issues reported and enhancements based on user feedback. The following is a general overview of those fixes and enhancements that will occur on Sunday, January 22.

# What's Fixed in Clarity

### 1. **PD Prescription:**

• Visonex fixed an issue in PD prescriptions that prevented staff from selecting the Final fill in the Cycles/Exchanges section of new orders.



### 2. **PD Prescription:**

• Visonex updated the Fill Volume range in Cycles/Exchanges from 5000 to 7000.

## 3. Password Reset Code email, give instructions:

 Visonex has added the option to Print Password Reset Code instructions. They also added instructions for when a Password reset code is e-mailed to a user.



- 4. Insurance Policies-Increase character limit for Authorization number:
  - Per client feedback, Visonex increased the character limit to 25 characters for the Authorization number found at **Registration>Insurance** Information>Policies.

#### **5.** Nursing home information update:

- Visonex updated the Registration>Nursing Home History to accommodate sending Nursing Home information to EQRS.
- Staff will now need to complete the Reason when completing the form.
- The Clinic Nursing Home History Report will now include the Reason for the Nursing Home.

### 8. RTC>Nurse Assessment

- Infection Assessment has been modified. Most fields have been removed.
- Any infection will only be charted in **Patient>Patient Infections**
- Remaining items:
  - i. Patient Infection Link,
  - ii. Review Suspected or Confirmed Infections (last 90 days),
  - iii. Review Anti-infective medications (last 90 days)
