













Clarity Tip Sheet: Patient Identifiers for Isolation

Rationale: Northwest Kidney Centers can only accommodate patients who require permanent isolation precautions at select facilities.


To designate which patients require ongoing isolation due to Hepatitis B positive status, utilize the following Clarity tools:

Auditing and Removing Isolation Status

Staff should follow the isolation guidelines for each type of permanent or temporary isolation status. For temporary isolation precautions that are no longer needed, the Treatment Alert should be discontinued. The Patient Identifier Comments box in General Information should only be used for Hepatitis B positive patients.
