

Clarity Monthly Update

September 2025

General Information

Renvio regularly updates Clarity with fixes to issues reported and enhancements based on user feedback. The following is a general overview of those fixes and enhancements that will be released on Sunday, September 21, 2025. You will see these updates starting Monday, September 22.

What's New or Fixed in Clarity

1. Medications – Medication screen updated for Antibiotics

- The antibiotics & anti-infectives have a hard stop, forcing the RNs to select if related to ESRD or AKI before saving the order.
 - The Tip Sheet how to enter the order is available on K-Net > Clarity > Tip Sheets > Medication Screen for IV Antibiotic Orders.

2. Pre-Dialysis Information (2728) Form Updates


- On the 2728 forms, users were unable to update the start date for Cause of Renal Failure that transfers automatically to Problem List. If the Date of Regular Dialysis Began was saved incorrectly & later updated, the date associated with the Primary Cause of Renal Failure will now also update within the Problem List.
- Previously, when two or more 2728 Forms were added to a patient's record, the Primary Cause of Renal Failure code and Date Regular Dialysis Began would update automatically to the newest version. Renvio made an update to allow multiple 2728 Forms to exist independently of one another.


3. Patient Chart View – Patient Identifier

- The floating patient identifier will now appear in Patient Chart View in the same way it appears in Clarity and assessment.



4. Patient Chart View - Immunization

- The tab for "Request Immunization History" was moved to the left side of the screen.



5. Reports – Medication Labels

- The medication labels will be displayed in a new sequence:
 - Previously, the labels were sorted by *Medication > Shift > Patient*.
 - Going forward, the labels will be sorted by *Patient > Medication*.

6. General Information – 2nd address line not appearing in Patient Chart View

- With the last release Renvio made an update with the 2nd address line. With this update the 2nd line was not crossing into Patient Chart View. That has now been resolved.

7. Billing Worksheet – Kt/V displaying as 8.88 incorrectly

- Renvio fixed an issue on the Billing Worksheet Expanded where it was displaying the Kt/V as 8.88, but the patient had the justification for extra treatments.
