

Clarity Monthly Update

November 2025

General Information

Renvio regularly updates Clarity with fixes to issues reported and enhancements based on user feedback. The following is a general overview of those fixes and enhancements that will be released on Sunday, November 16, 2025. You will see these updates starting Monday, November 17th.

What's New or Fixed in Clarity

1. Medication Management tool – Doxercalciferol and Paricalcitol

- Medication Management tool has been updated to ensure **the last five doses of doxercalciferol and paricalcitol now display accurately and consistently**. This enhancement improves visibility of recent dosing history for both medications.

2. Visit Management – unable to sign off Self Admin Medications

- Renvio fixed the issue where RNs were unable to save Self Admin medications on treatments that crossed from Patient Portal.

3. Pre-Dialysis Information (2728) Form Updates

- Previously, when two or more 2728 Forms were added to a patient's record, the Primary Cause of Renal Failure code and Date Regular Dialysis Began would update automatically to the newest version. Renvio made an update to allow multiple 2728 Forms to exist independently of one another.
- Renvio fixed the issue when entering in the second 2728 that some of the initial 2728 dates were updating. Now everything that was originally entered on the first 2728 will remain the same when entering in the second 2728

4. Reports

➤ Custom Report – Increase speed

- Renvio fixed an issue where custom reports were taking longer to generate. Staff will now see custom reports generate quicker.

➤ Billing Reports – Fix spelling error

- Renvio fixed the incorrect spelling of occurrence in the Key Lab Results section in the billing reports

➤ Clinic Hospitalization & Consultation Report

- Renvio fixed the issue where the report will no longer total up blank discharge diagnosis.

5. New Checklist Library Item

- A new section called **“Advance Care Planning Discussion”** will be available for use within the Patient Assessment library. This item is designed to guide providers through key topics related to advance care planning, ensuring that discussions are documented consistently and thoroughly. NKC is not immediately implementing this newly created section in any current Patient Assessment.
